ORDINANCE NO. 06-620 AMENDING THE CODE OF ORDINANCES OF THE CITY OF HUMBLE, TEXAS, BY ADDING TO CHAPTER 22 THEREOF A NEW ARTICLE III; PROVIDING FOR THE REGULATION OF TRANSIENT RETAIL BUSINESSES; PROHIBITING THE OPERATION OF A TRANSIENT RETAIL BUSINESS FROM PUBLIC ROADWAY RIGHTS OF WAY; PROVIDING CERTAIN EXCEPTIONS; PROVIDING FOR THE ISSUANCE OF TRANSIENT RETAIL BUSINESS LICENSES; ESTABLISHING A LICENSE ISSUANCE FEE; PROVIDING FOR THE DISPLAY OF TRANSIENT RETAIL LICENSES; PROVIDING OTHER PROVISIONS RELATED TO THE SUBJECT; PROVIDING A PENALTY OF AN AMOUNT NOT TO EXCEED \$500.00 FOR EACH VIOLATION OF ANY PROVISION HEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HUMBLE, TEXAS, BY ADDING TO CHAPTER 22 THEREOF A NEW ARTICLE III; PROVIDING FOR THE REGULATION OF TRANSIENT RETAIL BUSINESSES; PROHIBITING THE OPERATION OF A TRANSIENT RETAIL BUSINESS FROM PUBLIC ROADWAY RIGHTS OF WAY; PROVIDING CERTAIN EXCEPTIONS; PROVIDING FOR THE ISSUANCE OF TRANSIENT RETAIL BUSINESS LICENSES; ESTABLISHING A LICENSE ISSUANCE FEE; PROVIDING FOR THE DISPLAY OF TRANSIENT RETAIL LICENSES; PROVIDING OTHER

PROVISIONS RELATED TO THE SUBJECT; PROVIDING A PENALTY OF AN AMOUNT NOT TO EXCEED \$ 500.00 FOR EACH VIOLATION OF ANY PROVISION HEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY

RESOLUTION NO. 06-652

A RESOLUTION IN SUPPORT OF THE SUBMISSION OF A TAX CREDIT APPLICATION AND THE ALLOCATION OF TAX CREDIT TO ENABLE THE REHABILITATION OF COUNTRYSIDE VILLAGE APARTMENTS

- WHEREAS, NHDC Apartments Countyside Village, L. P. has proposed a development for affordable rental housing at 625 Wilson Road named Countryside Village in Humble, Harris County, Texas; and
- WHEREAS, NHDC Apartments Countryside Village, L.P. intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2006 Housing Tax for Countryside Village; and
- WHEREAS, Title 10 §50.5(a)(7), Texas Administrative Code, states that if a Development is located within a municipality that has more than twice the state average of units per capita supported by Housing Tax Credits at the time the Application round begins may be ineligible for funding unless the applicant "has obtained prior approval of the development from the governing body of the appropriate municipality or county containing the development";

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS that the City is in support of the submission of a tax credit application and the allocation of tax credit to enable the rehabilitation of Countryside Village Apartments.
