
1. Call to order.

This form should be completed and returned to the City Secretary no later than ten (10) minutes prior to the beginning of the meeting. Upon stepping to the podium the speaker must state their name, and city of residence. **Each speaker's remarks are limited to three (3) minutes.** The City Council will listen and receive the information presented by the speaker, Ask staff to look into the matter, or place the issue on a future agenda. Topics of operation concerns shall be directed to the City Manager. Comments should not personally attack other speakers, Council or Staff.
4. Consent Agenda: Ministerial or "housekeeping" items that can be voted on in one motion as allowed by law. Items may be removed from the Consent Agenda for individual consideration and discussed or acted upon by a majority vote of the Council.

5. Presentation, possible action, and discussion on approval of Ordinance 19-854, amending Chapter 44 "Traffic and Vehicles", Articles III "Wreckers and Vehicle Storage Facilities", Division 1 "Generally" Section 222 "Required Equipment", Subsection 1, 8, and 10, by amending equipment requirements and creating a new Subsection 11; Section 224 "Charges, Police-Authorized and Nonconsent", Subsections A and B, by amending the maximum allowable charges by wrecker services and creating a new Subsection D; Division 2 "Vehicle Storage Facilities",

Section 249 “Charges”, Subsections A, B and C by amending the maximum allowable charges by vehicle storage facilities; Section 277 “Required Classes”, Subsections C by removing a class of permit; Section 284 “Additional Vehicles”, Subsection E by amending provisions related to allowed wreckers for response; providing for a savings/repealing clause; severability and an effective date.

6. Presentation, possible action, and discussion on approval of Resolution 19-816, supporting the Metropolitan Transit Authority’s Metronext Transit Plan, subsequent bond election and extension of the General Mobility Program.

Presentation, possible action, and discussion on approval of a proposed variance request by Candlewood Homes, in the Timberwood Section Ten Subdivision, to allow minimum lot size of 60 feet in width and not less than 110 feet in depth in order to match the unique characteristics of the existing Timberwood neighborhood, located south of Oriole Lane, east of Pheasant Run, west of Garners Bayou, and north of Reinhardt Bayou, Humble, Texas.
8. Presentation, possible action, and discussion on approval of the Development Plat for the Humble Park Maintenance Building, a subdivision of 7.7865 acres or 339,179 sq. ft. of land situated in the Wherry B. Adam Survey, Abstract No 95, Harris County, Texas located on South Houston Avenue.

Presentation, possible action, and discussion on approval of a Parade Permit Application for the Rockstar Cares Breast Cancer Walk on October 12, 2019, beginning at 8:00 a.m. to 12:00 p.m., and closing portions of Main Street, Railroad Avenue, Avenue A through Avenue H, and Granberry Street up to South Avenue G, through South Avenue B. Starts at 10:00 a.m. at Bender Avenue and Main Street. Parade will end at Humble Municipal Court House.
