5. ORDINANCE NO. 08-652 AMENDING THE CODE OF ORDINANCES OF THE CITY OF HUMBLE, TEXAS, BY DELETING SECTION 46-95 INTERCEPTORS AND SUBSTITUTING THEREFORE A NEW SECTION 46-95 GREASE AND GRIT TRAPS; AMENDING SECTION 46-100 ENFORCEMENT; AND PROVIDING FOR SEVERABILITY

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HUMBLE, TEXAS, BY AMENDING CHAPTER 46 DELETING SECTION 46-95 INTERCEPTORS AND SUBSTITUTING THEREFORE A NEW SECTION 46-95 GREASE AND GRIT TRAPS; AMENDING SECTION 46-100 ENFORCEMENT; AND PROVIDING FOR SEVERABILITY

6. **ORDINANCE NO. 08-653 AMENDING CHAPTER 44, TRAFFIC AND VEHICLES, OF ITS CODE OF ORDINANCES BY THE ADDITION OF NEW SECTIONS 44-84 THROUGH 44-86, PROVIDING ADDITIONAL REGULATIONS AND RESTRICTIONS RELATED TO THE PARKING OF VEHICLES AND TRAILERS ON PUBLIC STREETS; PROHIBITING THE PARKING OF COMMERCIAL MOTOR VEHICLES, TRUCK TRACTORS, TRAILERS, AND SEMITRAILERS ON A PUBLIC STREET; PROHIBITING THE PARKING OF AIRPLANES, BOAT TRAILERS, CAMPERS, FARM IMPLEMENTS, HORSE TRAILERS, HOUSE TRAILERS, UTILITY TRAILERS AND OTHER SIMILAR VEHICLES WITH OR WITHOUT MOTIVE POWER ON A PUBLIC STREET; PROVIDING CERTAIN DEFENSES AND EXCEPTIONS; PROVIDING A PRESUMPTION THAT THE OWNER OF VEHICLE SHALL BE PRESUMED TO HAVE BEEN THE OPERATOR OF A VEHICLE WHEN A VEHICLE IS PARKED UNATTENDED; PROVIDING A PENALTY UP TO \$200.00 PER DAY FOR VIOLATIONS; PROVIDING A SAVING PROVISIONS; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, AMENDING CHAPTER 44, TRAFFIC AND VEHICLES, OF ITS CODE OF ORDINANCES BY THE ADDITION OF NEW SECTIONS 44-84 AND 44-85, PROVIDING ADDITIONAL REGULATIONS AND RESTRICTIONS RELATED TO THE PARKING OF VEHICLES AND TRAILERS ON PUBLIC STREETS; PROHIBITING THE PARKING OF COMMERCIAL MOTOR VEHICLES, TRUCK TRACTORS, TRAILERS, AND SEMITRAILERS ON A PUBLIC STREET; PROVIDING CERTAIN DEFENSES AND EXCEPTIONS; PROVIDING A PRESUMPTION THAT THE OWNER OF VEHICLE SHALL BE PRESUMED TO HAVE BEEN THE OPERATOR OF A VEHICLE WHEN A VEHICLE IS PARKED UNATTENDED; PROVIDING A PENALTY UP TO \$200.00 PER DAY FOR VIOLATIONS; PROVIDING A SAVINGS PROVISIONS; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE
