8. RECOMMENDATIONS FROM CITY OF HUMBLE INSURANCE COMMITTEE - EMPLOYEE GROUP INSURANCE

City Manager Boeske, a member of the Insurance Committee, presented the recommendations of the committee for dental insurance, life/accidental death and dismemberment insurance and the gap plan to the mayor and councilmembers for approval. The committee recommended that the dental insurance be awarded to Hartford and the life/accidental death insurance be awarded to Hartford with a increase of \$ 10,000.00 to \$50,000.00 in life and \$ 100,000.00 for accidental death and to keep the gap plan with American Fidelity but increase the coverage. The premiums would be:

Dental:
