Early voting by personal appearance will be conducted each weekday at the office of the city secretary located in City Hall at 114 West Higgins, Humble Texas. Early voting will be held April 26, 2010 - April 30, 2010 between the hours of 8:00 a.m. and 5:00 p.m. On May 3 and 4, 2010 early voting will be held from 7:00 a.m. to 7:00 p.m.
