I further hereby certify, pursuant to Section 2.052, Texas Election Code, that the candidates are unopposed for election to the offices to be on the ballot in the May 8, 2010, municipal general election, as follows:

Allen L. Lee is unopposed for election to the office of Councilmember Position No. 3.

Allan J. Steagall is unopposed for election to the office of Councilmember Position No.

Merle Aaron is unopposed for election to the office of Councilmember Position No. 5.

I further certify that no candidates' names are to be placed on lists of write-in candidates for the positions of Councilmember Position No. 3, Councilmember Position No. 4 or Councilmember Position No. 5 to appear on the ballot in the May 8, 2010 municipal general election and that there are no propositions to appear on the ballot in said election.

CITY OF HUMBLE ORDINANCE NO. 10-685 DECLARING THE UNOPPOSED CANDIDATES FOR COUNCILMEMBER POSITION NO. 3, COUNCILMEMBER POSITION NO. 4 AND COUNCILMEMBER POSITION NO. 5 AS ELECTED; PROVIDING THAT THE MAY 8, 2010 MUNICIPAL GENERAL ELECTION SHALL NOT BE HELD; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; FINDING AND DETERMINING THAT THE MEETING AT WHICH THE ORDINANCE WAS PASSED WAS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND PROVIDING FOR AN EFFECTIVE DATE

City Manager Boeske presented Ordinance No. 10-685 to the mayor and councilmembers and recommended approval.

ORDINANCE NO. 10-685

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS DECLARING THE UNOPPOSED CANDIDATES FOR COUNCILMEMBER POSITION NO. 3, COUNCILMEMBER POSITION NO. 4 AND COUNCILMEMBER POSITION NO. 5 AS ELECTED; PROVIDING THAT THE MAY 8, 2010 MUNICIPAL GENERAL ELECTION SHALL NOT BE HELD; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; FINDING AND DETERMINING THAT THE MEETING AT WHICH THE ORDINANCE AS PASSED WAS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, pursuant to City of Humble, Texas Ordinance No. 10-684, passed, approved and adopted January 28, 2010, a municipal general election was ordered to be held on May 8, 2010 for the purpose of electing three officials of the City, to wit: Councilmember Position No. 3, Councilmember Position No. 4 and Councilmember Position No. 5; and
- WHEREAS, pursuant to Sections 143.007 and 146.054, Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's municipal general election have expired; and
- WHEREAS, the City Secretary, in accordance with Section 2.052, Texas Election Code, has certified in writing to the City Council that Allen L. Lee is unopposed for election to the office of Councilmember Position No. 3, Allan J. Steagall is unopposed for election to the office of Councilmember Position No. 4, and Merle Aaron is unopposed for election to the office of Councilmember Position No. 5; and
- WHEREAS, the City Council hereby finds and determines that the candidates whose names are to appear on the ballot in said election are unopposed, there are no declared write-in candidates and no propositions to appear on the ballot for said election;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS THAT:

1.

The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

2.

In accordance with Section 2.053(a), Texas Election Code, that the following unopposed candidates are hereby declared duly elected to the respective offices shown and shall be issued a certificate of election following the date on which the municipal general election for Councilmember Position No. 3, Councilmember Position No. 4 and Councilmember Position No. 5 was to have been held:

Councilmember Position No. 3 - Allen L. Lee Councilmember Position No. 4 - Allan J. Steagall Councilmember Position No. 5 - Merle Aaron Pursuant to Section 2.053(b), Texas Election Code, the municipal general election for City Councilman Positions Nos. 3, 4 and 5 heretofore called and ordered by Ordinance No. 10-684 for May 8, 2010 shall not be held and is hereby canceled.

4.

The City Secretary is hereby directed to cause a copy of this Ordinance to be posted on election day, same being May 8, 2010, at the polling place that would have been used in such election.

5.

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

6.

The Code of Ordinances of the City of Humble, Texas, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

7.

Should any section, paragraph, sentence, clause, phrase or word of this ordinance be declared unconstitutional or invalid for any purpose by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby, and to this end the provisions of this ordinance are declared to be severable.

8.

It is hereby found and determined that the meeting at which this ordinance was passed was open to the public as required by Section 551.001 et seq., Texas Government Code, and that advance public notice of the time, place and purpose of said meeting was given.

9.

This ordinance shall take effect upon passage.

PASSED, APPROVED and ADOPTED this the 25th day of March, 2010.

8. AUTHORIZE CLOSURE OF TOWNSEN WEST EB FOR 48 HOURS FOR REPAIR WORK AT TRANSITION FROM TWO LANES TO FOUR LANES

City Manager Boeske presented a request from Barry Brock, the Director of Public Works, to close Townsen West to eastbound traffic between FM 1960 and Highway 59. The closure

is necessary for the contractor, SER Construction, to make repairs to the asphalt transition from the existing two lane traffic to four lane traffic. To remill and perform the overlay repairs should only take two days to complete. An illuminated traffic board will be installed two days prior to the closure to notify the public. At this time the contractor has projected the repairs will be done March 29th and 30th. Councilmember Merle Aaron moved to authorize the closure of Townsen West for four eight hours for repair work.
