6. ORDINANCE NO. 12-701 ESTABLISH FIRE ZONE AT THE WESTERN END OF WARWICK DRIVE OR 60 FEET OF THE EASTERN PROPERTY LINE 9669 FM 1960 BYPASS WEST OR BETTER DESCRIBE AS THE EAST AND WEST ENTRANCE TO THE CITY OF HUMBLE WATER PLANT #1 LOCATED AT 19903 FIELDTREE DRIVE

City Manager Darrell Boeske presented Ordinance No. 12-701 to the mayor and councilmembers and recommended approval.

## ORDINANCE NO. 12-701

AN ORDINANCE OF THE CITY OF HUMBLE ESTABLISHING A FIRE LANE NO PARKING ZONE AT THE WESTERN END OF WARWICK DRIVE AND 60 FEET OF THE EASTERN PROPERTY LINE AT 9669 FM 1960 BYPASS WEST OR BETTER DESCRIBED AS THE EAST AND WEST ENTRANCE TO THE CITY OF HUMBLE WATER PLANT #1 LOCATED AT 19903 FIELDTREE DRIVE

WHEREAS, the City of Humble Fire Marshal has declared the necessity of a Fire Lane with No Parking zone to facilitate an emergency entrance into and out of the Northshire Subdivision: and

WHEREAS, this Fire Zone will enhance the services of the City of Humble Fire Department to respond to emergency calls from the subdivision; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

Section 1. A Fire Lane No Parking zone has been established at the western end of Warwick Drive and 60 feet of the eastern property line at 9669 FM 1960 Bypass West or better described as the east and west entrance to the City of Humble Water Plant # 1 located at 19903 Fieldtree Drive as shown on Exhibit "A"; and

Section 2. Any person violating the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in any sum not more that Two Hundred Dollars (\$ 200.00).

Section 3. This ordinance shall be in effect ten (10) days after passage.

He stated the company wants to do small reconfigurations on the top of antennas and asked for approval of the request. ## 10. CHANGE ORDER # 1 RIGHT TURNING LANES WILSON ROAD AND WILL CLAYTON PARKWAY

City Manager Boeske presented Change Order # 1 for the Wilson Road and Will Clayton Parkway Right Turning Lanes Project. The change order amount is \$ 11,027.99 and will make the new contract amount \$ 701,482.99 and also increases the construction days by 102 for a total of 237 construction days. The change order was necessary for the adjustment of a 12" water line that was in direct conflict with the proposed storm sewer line on the northwest corner of Wilson Road and Will Clayton Parkway. The additional construction days were necessary for 30 calendar days for the relocation of the water line and 72 calendar days for down time for the relocation of Century Link telephone cables. Councilmember Steagall moved to approve item # 10.
