City Manager Darrell Boeske presented Ordinance No. 13-713 to the mayor and councilmembers for approval.

Notice is hereby given that a general election has been ordered to be held on the 11th day of May, 2013 for the purpose of electing the following City Officials:

COUNCILMEMBER PLACE NO. 1

COUNCILMEMBER PLACE NO. 2

The entire corporate limits of the city shall constitute one election precinct and the polling place for said election shall be City Hall located at 114 West Higgins, Humble, Texas. The polls will open at 7:00 a.m. and close at 7:00 p.m.

Early voting by personal appearance will be conducted each weekday at the office of the city secretary located in City Hall at 114 West Higgins, Humble Texas. Early voting will be held April 29 - May 3, 2013 between the hours of 8:00 a.m. and 5:00 p.m. On May 6 and 7, 2013 early voting will be held from 7:00 a.m. to 7:00 p.m.

No person shall vote at said election unless they are qualified to vote under the Constitution and laws of the State of Texas and the City of Humble Charter regulating election when not in conflict with the provisions of the statutes relating thereto.

7. ORDINANCE NO.13-714 CITY OF HUMBLE CODE OF ORDINANCES SECTION 12 BUILDING AND BUILDING REGULATIONS, ARTICLE VII, TOWERS, SECTION 12-328 DEED RESTRICTION TITLE REPORT; AND MAKING OTHER FINDINGS AND PROVISIONS RELATED THERETO

City Manager Boeske presented Ordinance No. 130-714 to the mayor and councilmembers for approval.

ORDINANCE NO. 13-714

AN ORDINANCE AMENDING THE CITY OF HUMBLE CODE OF ORDINANCES, CHAPTER 12, BUILDINGS AND BUILDING REGULATIONS, ARTICLE VII, TOWERS, SECTION 12-328 DEED

RESTRICTION TITLE REPORT; AND MAKING OTHER FINDINGS AND PROVISIONS RELATED THERETO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, THAT:

<u>Section 1</u>. That Chapter 12, Article VII, Section 12-328 is hereby amended to read as follows:

"Section 12-328 Deed restriction title report

- (a) Every applicant for a tower permit or a waiver shall furnish to the city manager a title report, from a title company doing business in the county, that the lot or tract upon which the proposed tower is to be located is not included within a recorded platted subdivision subject to enforceable, valid and unexpired deed restrictions which limit the use of such lot or tract to residential purposes. The title report shall be accompanied by certified copies of any instruments containing restrictions purporting to be applicable to the lot or tract in question, any instrument of revocation or termination thereof, any declaratory judgement order pertaining to the use of the property, or any other recorded document containing restrictions that pertain to the use of the property.
- (b) A tower permit shall not be issued until the requested title report and supporting documentation has been produced. Any permit issued on the basis or erroneous documentation known to the applicant or a title report which contains false information know to the applicant is void with the same force and effect as if it had never been issued and without the necessity of any action by the city or any other person or agency. A tower permit shall not be issued for the construction or alteration of a tower if the use of the intended use will be in violation of the recorded deed restrictions."
- <u>Section 2</u>. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Humble, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.
- <u>Section 3</u>. Upon the passage of this Ordinance, the City Secretary is directed to publish this Ordinance in accordance with the provisions of Article II, Section 13 of the Charter of the City of Humble and to note on this Ordinance and on the record thereof the fact that this Ordinance has been published as required by the Charter, including the date of such publication.

City Manager Boeske stated that the amendments to the ordinance were necessary as it is against State law to require the title company to do a deed restriction affidavit. The

amendment provides that the title company submit a title search on the property. Councilmember Steagall moved to approve Ordinance No. 13-714.

8. ENGINEERING PROPOSAL WITH ARKK, L.L.C. FOR 2013 CONCRETE PAVEMENT IMPROVEMENTS PROJECT - AREA NORTH OF FIRST STREET BOUNDED BY CHARLES STREET, SEVENTH STREET, AND HOUSTON AVENUE; WEST MAIN, US 59 TO RAILROAD; CHARLES STREET, HIGGINS TO FIRST STREET; SOUTH MEMORIAL, MEMORIAL TO DEAD END; BENDER AT TOWNSHIP DRAINAGE IMPROVEMENTS; INTERCONTINENTAL VILLAGE WATER LINE REPLACEMENT; VARIOUS SIDEWALKS WITHIN THE COMMERCIAL AND SCHOOL AREAS - AND AUTHORIZATION TO ADVERTISE FOR BIDS

City Manager Boeske presented an engineering proposal from ARKK, L.L.C. for the 2013 Concrete Pavement Improvements Project and a request for authorization to advertise for bids. The streets in this project are: the area north of First Street bounded by Charles Street, Seventh Street and Houston Avenue; West Main, U.S. 59 to Railroad; Charles Street, Higgins to First Street; South Memorial, Memorial to dead end; Bender at Township drainage improvements; Intercontinental Village water line replacement; various sidewalks within the commercial and school areas. The estimated cost for the improvements project is \$ 5,700,000.00. The engineering fees are Design Phase Services - \$ 526,950.00 and the Construction Phase Services - \$126,150.00 with the total contract authorization amount not to exceed \$ 653,100.00. Time and materials charges and additional services beyond those described in the Scope of Services will be invoiced on the basis of direct labor costs times a factor of 2.99 and direct cost plus 10%. Mileage will be charged at \$0.55 per mile. No additional services will be performed or invoiced without prior authorization from the City of Humble. Councilmember Lee moved to approve the engineering proposal from ARKK and the authorization to advertise for bids.

9. ENGINEERING PROPOSAL WITH ARKK, L.L.C. FOR 2013 ASPHALT PAVEMENT IMPROVEMENTS PROJECT - WILSON ROAD FROM WILL CLAYTON PARKWAY TO ATASCOCITA ROAD; WEST HIGGINS FROM US 59 TO RAILROAD AVENUE; NORTH RAILROAD AVENUE FROM HIGGINS TO FIRST STREET; AVENUE D SOUTH OF STAITTI; AVENUE H FROM MAIN TO GRANBERRY; GRANBERRY FROM AVENUE H TO HOUSTON AVENUE; GRACE LANE; WINDSWEPT FROM MONTGOMERY TO HCFCD DITCH; ANNE AVENUE FROM WINDSWEPT TO SHARON; J&L RANCHLAND SIDE STREETS - AND AUTHORIZATION TO ADVERTISE FOR BIDS

City Manager Boeske presented an engineering proposal from ARKK, L.L.C. for the 2013 Asphalt Pavement Improvements Project and a request for authorization to advertise for bids. The streets involved in this project are: Wilson Road from Will Clayton Parkway to Atascocita Road; West Higgins from US 59 to Railroad Avenue; North Railroad Avenue from Higgins to First Street; Avenue D south of Staitti; Avenue H from Main to Granberry; Granberry from Avenue H to Houston Avenue; Grace Lane; Windswept from Montgomery to HCFCD ditch; Anne Avenue from Windswept to Sharon; J&L Ranchland side streets. The estimated contraction cost for the asphalt paving improvement project is \$ 5,100,000.00. The engineering fees for ARKK are Design Phase - \$457,200.00 and the Construction Phase - 109,000.00 with the total contract authorization amount is not to exceed \$566,200.00. Time and materials charges and additional services beyond those described in the Scope of Services will be invoiced on the basis of direct labor costs times a factor of 2.99 and direct cost plus 10%. Mileage will be charged at \$0.55 per mile. No additional services will be performed or invoiced without prior authorization from the City of Humble. Councilmember Steagall moved to approve item # 9.
