ADOPTION OF ORDINANCE 17-795 AMENDING CHAPTER 12, "BUILDINGS AND BUILDING REGULATIONS", ARTICLE XI "DEVELOPMENT STANDARDS", SECTION 500 "EXTERIOR CONSTRUCTION REQUIREMENTS FOR NON-RESIDENTIAL AND MULTI-FAMILY RESIDENTIAL BUILDINGS", SECTION B "DEFINITIONS", BY ADDING A DEFINITION FOR STUCCO; AND AMENDING SECTION C "EXTERIOR CONSTRUCTION REQUIREMENTS", ITEM 2 "NON-RESIDENTIAL BUILDING DEVELOPMENT", BY PERMITTING A CERTAIN PERCENTAGE OF STUCCO TO BE UTILIZED IN EXTERIOR CONSTRUCTION AND DELETING SUBSECTION (B) IN ITS ENTIRETY; MAKING CERTAIN FINDINGS; AND PROVIDING FOR SEVERABILITY.

City Manager Boske asked for approval of the Ordinance.


