ORDINANCE AUTHORIZING THE REDEMPTION PRIOR TO MATURITY
OF OUTSTANDING CITY OF HUMBLE, TEXAS CERTIFICATES OF
OBLIGATION, SERIES 1998

THE STATE OF TEXAS §
COUNTY OF HARRIS §

WHEREAS, the City Council (the "City Council") of the City of Humble, Texas (the "City"), has heretofore issued its Certificates of Obligation, Series 1998 (the "Certificates") pursuant to an ordinance of the City, dated July 13, 1998 (the "Certificate Ordinance"); and

WHEREAS, pursuant to the Certificate Ordinance, the City has the right to redeem all or a portion of the Certificates in advance of their maturities; and

WHEREAS, the City desires to redeem the outstanding Certificates, as more specifically described in Section 3 herein (the "Redeemed Certificates") in advance of their maturities on August 5, 2013 (the "Redemption Date"); and

WHEREAS, the Certificate Ordinance authorizes the City to accomplish such redemption by depositing directly with The Bank of New York Mellon Trust Company, N.A., successor to Chase Bank of Texas, National Association, the paying agent for the Certificates (the "Paying Agent/Registrar"), available funds of the City, in an amount sufficient to provide for the payment or redemption of the Redeemed Certificates on the Redemption Date; and

WHEREAS, upon the deposit of funds referred to above, the Redeemed Certificates shall no longer be regarded as being outstanding, except for the purpose of being paid pursuant to such deposit, and the pledges, liens, trust and all other covenants, provisions, terms and conditions of the Certificate Ordinance shall be discharged, terminated and defeased; NOW, THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

1. Recitals. It is hereby found and determined that the matter and facts set out in the recitals to this ordinance are true and correct and incorporated herein for all purposes. All capitalized terms not otherwise defined in the recitals to this ordinance shall have the meaning set forth in the Certificate Ordinance.

2. Deposit with Paying Agent/Registrar. Available funds of the City in an amount sufficient to pay all principal of and interest on the Redeemed Certificates due on the Redemption Date and all costs incurred in the redemption of the Redeemed Certificates shall be deposited directly with the Paying Agent/Registrar on or before the Redemption Date.

3. Redemption Prior to Maturity of Redeemed Certificates. The City hereby calls the Certificates described below for redemption prior to maturity on the Redemption Date, at a

price of par plus accrued interest to the Redemption Date, and authorizes and directs notice of such redemption to be given in accordance with the terms of the Certificate Ordinance:

4. Related Matters. To satisfy in a timely manner all of the City's obligations under this ordinance, the Mayor, the Director of Finance and all other appropriate officers and agents of the City are hereby authorized and directed to take all actions that are reasonably necessary to provide for the redemption of the Redeemed Certificates, including, without limitation, paying any fees or expenses required in connection with the redemption and executing and delivering on behalf of the City all certificates, consents, receipts, requests, and other documents as may be necessary to direct the application of funds of the City consistent with the provisions of this ordinance.

5. Bond Counsel. The City hereby approves the engagement of Bracewell & Giuliani LLP as bond counsel and authorizes the transfer of the City's files from the law firm of Vinson & Elkins L.L.P. to Bracewell & Giuliani LLP.

6. No Personal Liability. No recourse shall be had for payment of principal of or interest on any Certificates or for any claim based thereon against any member of the City Council or employee of the City.

7. Open Meeting. It is hereby officially found and determined that the meeting at which this ordinance was adopted was open to the public, and that public notice of the time, place and purpose of said meeting was given, all as required by Chapter 551, Texas Government Code.

8. Effective Date. This Ordinance shall take effect immediately upon its passage.

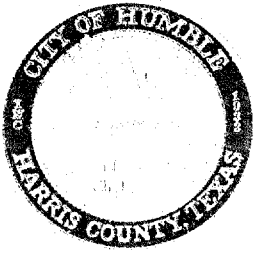

Dear Gentlemen:

When a disaster event occurs that produces large amounts of debris, effective coordination is required between the Public Assistance Applicant (the city), State and FEMA to ensure that debris removal operations are efficient, effective, and eligible for FEMA Public Assistance Grant funding. Eligible Public Assistance Applicants are required to monitor debris removal operations and document eligible quantities and reasonable expenses to ensure that the debris removal and disposal work is eligible for Public Assistance grant funding. Failure to do so properly may **jeopardize** this funding.

You have, in the past, approved a pre-event contract for disaster debris clearance and removal services. The companion agreement is for debris monitoring activities. As stated above, federal law requires the city to utilize debris monitoring to support the oversight and management of the debris removal activities. The debris monitoring services include, but are not limited to, truck certification, environmental permitting, debris collection monitoring, debris disposal monitoring, FEMA reimbursement accounting, and debris removal contractor invoice reconciliation.

Through the Houston-Galveston Area Council purchasing cooperative (HGACBuy) the city can directly contract with Science Application International Corporation (SAIC) for debris monitoring services. You will find attached a copy of the Debris Monitoring Service Agreement with S.A.I.C. for your consideration and hopefully your approval.

1. **Scope of Services:** Contractor and Client agree Contractor will perform services associated with disaster preparedness and emergency response & recovery services as described in the Scope of Services attached as Exhibit A. Task Orders shall be issued for specific deliverables under this Agreement. Such deliverables to be provided by Contractor will be determined by Client and specified in writing on each Task Order prior to commencing work.
2. **Term:** The term of this Agreement shall begin on June 1, 2013 through May 31, 2016 with automatic annual renewals, unless either party elects to withdraw.
3. **Independent Contractor:** Contractor is an independent contractor and is not an employee of Client. Services performed by Contractor under this Agreement are solely for the benefit of the Client. Nothing contained in this Agreement creates any duties on the part of Contractor toward any person not a party to this Agreement.
4. **Standard of Care:** Contractor will perform services under this Agreement with the degree of skill and diligence and judgment normally exercised by recognized professional firms performing services of the same or substantially similar nature. No other warranty or guarantee, expressed or implied, is made with respect to the services furnished under this Agreement and all implied warranties are disclaimed.
5. **Changes/Amendments:** This Agreement and its exhibits constitute the entire agreement between the Parties and together with its exhibits supersede any prior written or oral agreements. This Agreement may not be amended, modified or changed except by written amendment executed by both Parties. The estimate of the level of effort, schedule and payment required to complete the Scope of Services,

as Contractor understands it, is reflected herein. Services not expressly set forth in this Agreement or its exhibits are excluded. Contractor shall promptly notify Client if changes to the Scope of Services affect the schedule, level of effort or payment to Contractor and the schedule and payment shall be equitably adjusted.

6. **Uncontrollable Forces:** Neither the Client nor Contractor shall be considered to be in default of this Agreement if delays in or failure of performance shall be due to Uncontrollable Forces, the effect of which, by the exercise of reasonable diligence, the non-performing party could not avoid. The term "Uncontrollable Forces" shall mean any event which results in the prevention or delay of performance by a party of its obligations under this Agreement and which is beyond the reasonable control of the nonperforming party. It includes, but is not limited to fire, flood, earthquakes, explosion, strike, transportation, or equipment delays, act of war, Act of God, lightning, epidemic, war, riot, civil disturbance, sabotage, acts of terrorism and governmental actions outside the control of the Client. The schedule or payment under the Agreement shall be equitably adjusted, if necessary, to compensate Contractor for any additional costs due to the delay.

Neither party shall, however, be excused from performance if nonperformance is due to forces which are foreseeable, preventable, removable, or remediable, and which the nonperforming party could have, with the exercise of reasonable diligence, prevented, removed or remedied with reasonable dispatch. The nonperforming party shall, within a reasonable time of being prevented or delayed from performance by an uncontrollable force, give written notice to the other party describing the circumstances and uncontrollable forces preventing continued performance of the obligations of this Agreement.

7. **Fee for Services:** The fee for the services under this Agreement will be based on either a fixed fee basis or the actual hours of services furnished multiplied by Contractor's Billing Rates as set forth in Exhibit B, plus all reasonable expenses directly related to the services furnished under this Agreement.

Task Orders issued under this Agreement shall specify the contract type and project cost.

8. **Compensation:** Contractor shall bear the costs of performing all services under this Agreement, as directed by the Client, plus applicable permit and license fees and all maintenance costs required to maintain its vehicles and other equipment in a condition and manner adequate to accomplish and perform all services under this Agreement.

Client shall pay Contractor in accordance with paragraph 7 above, "Fee for Services" (Exhibit B) which is attached and incorporated herein by reference as part of this Agreement.

Contractor shall submit monthly invoice for services rendered.

Client will review invoices for acceptance within ten (10) calendar days of the date of the invoice to which Client shall immediately notify Contractor of any invoice discrepancies. Contractor and Client will work in good faith to resolve any such discrepancies within ten (10) days after notification. Should a discrepancy result in a partial rejection of any item(s) invoiced, Client shall proceed with partial payment within Net 30 days of the date of the invoice. If Client fails to make payment within thirty (30) days of the date of such invoice, interest compounded at the rate of one percent (1%) per month (retroactive to the first month outstanding) shall be charged and payable by Client on all amounts unpaid and outstanding (less any discrepant amount identified within the ten (10) day review period noted above). Under no circumstances shall payment of Contractor's invoices be contingent on reimbursement of Client by any third party authority or funding source. Any interest charges due from Client on past due invoices are in addition to amounts otherwise due under this Agreement. If Client fails to make any payment to Contractor as required hereunder, Contractor shall have the right exercisable in Contractor's sole discretion, in addition to its other rights and remedies, to cease further

9. **Indemnity:** Contractor agrees to defend, indemnify, and hold harmless Client from and against claims, judgments, and awards, as well as the reasonable costs related thereto (hereinafter collectively referred to as "Damages") to the extent such Damages result from the negligent or willful acts or omissions of Contractor occurring in the performance of its obligations hereunder.
10. **Insurance:** During the performance of the Services under this Agreement, Contractor shall maintain the following insurance policies:

11. **Work Product:** Client shall have the unrestricted right to use the documents, analyses and other data prepared by Contractor under this Agreement ("Work Products"); provided, however Client shall not rely on or use the Work Products for any purpose other than the purposes under this Agreement and the Work Products shall not be changed without the prior written approval of Contractor. If Client releases the Work Products to a third party without Contractor's prior written consent, or changes or uses the Work Products other than as intended hereunder, (a) Client does so at its sole risk and discretion and (b) Contractor shall not be liable for any claims or damages resulting from the change or use or connected with the release or any third party's use of the Work Products.
12. **Limitation of Liability:** Contractor's total liability to Client for any and all liabilities, claims or damages arising out of or relating to this Agreement, howsoever caused and regardless of the legal theory asserted, including breach of contract or warranty, tort, strict liability, statutory liability or otherwise, shall not, in the aggregate, exceed the amount actually paid to Contractor under this Agreement, or under the specific task order at issue, whichever is less.
13. **No Consequential Damages:** In no event shall either Contractor or Client be liable to the other for any punitive, exemplary, special, indirect, incidental or consequential damages (including, but not limited to, lost profits, lost business opportunities, loss of use or equipment down time, and loss of or corruption to data) arising out of or relating to this Agreement, regardless of the legal theory under which such damages are sought, and even if the parties have been advised of the possibility of such damages or loss.
14. **Information Provided by Others:** Client shall provide to Contractor in a timely manner any information Contractor indicates is needed to perform the services hereunder. Contractor may reasonably rely on the accuracy of information provided by Client and its representatives.

Such reimbursable costs may include, but are not limited to, cancellation fees, minimum consulting or material fees, and non-refundable charges or fees for third party products or services.
17. **Dispute Resolution:** Contractor and Client shall attempt to resolve conflicts or disputes under this Agreement in a fair and reasonable manner and agree that if resolution cannot be made to attempt to mediate the conflict by a professional mediator. If mediation does not settle any dispute or action which arises under this Agreement or which relates in any way to this Agreement or the subject matter of this Agreement within ninety (90) days after either party requests mediation, the dispute or conflict shall be subject to litigation.
18. **Successors and Assigns:** This Agreement is binding upon and will inure to the benefit of Client and Contractor and their respective successors and assigns. Neither party may assign its rights or obligations hereunder without the prior written consent of the other party.

20. **Severability:** The invalidity, illegality, or unenforceability of any provision of this Agreement, or the

occurrence of any event rendering any portion or provision of this Agreement void, shall in no way affect the validity or enforceability of any other portion or provision of the Agreement. Any void provision shall be deemed severed from the Agreement and the balance of the Agreement shall be construed and enforced as if the Agreement did not contain the particular portion or provision held to be void. The parties further agree to reform the Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this section shall not prevent the entire Agreement from being void should a provision which is of the essence of the Agreement be determined to be void.

21. **Governing Law and Venue:** This Agreement shall be governed by and interpreted according to the laws of the State of Texas. The venue for any and all legal action necessary to enforce the Agreement shall be Harris County.
22. **Access and Audits:** Contractor shall maintain adequate financial and program records to justify all charges, expenses, and costs incurred in estimating and performing the work under this Agreement for at least three (3) years following final payment to the Client as Federal Emergency Management Agency sub-grantee as required by FEMA's 322 Public Assistance Guide, page 114, as amended, or any similar regulation, policy, or document adopted by FEMA subsequent to the execution of this Agreement. The Client shall have access to all records, documents and information collected and/or maintained by others in the course of the administration of the Agreement. This information shall be made accessible at the Contractor's place of business to the Client, including the Comptroller's Office and/or its designees, for purposes of inspection, reproduction, and audit without restriction.
23. **Compliance with Laws:** In performance of the Services, Contractor will comply with applicable regulatory requirements including federal, state, special district, and local laws, rules, regulations, orders, codes, criteria and standards, and shall obtain all permits and licenses necessary to perform the Services under this Agreement at Contractor's own expense.
24. **Non-Discrimination:** The Contractor warrants and represents that all of its employees are treated equally during employment without regard to race, color, religion, gender, age or national origin.
25. **Waiver:** A waiver by either the Client or Contractor of any breach of this Agreement shall not be binding upon the waiving party unless such waiver is in writing. In the event of a written waiver, such a waiver shall not affect the waiving party's rights with respect to any other or further breach. The making or acceptance of a payment by either party with knowledge of the existence of a default or breach shall not operate or be construed to operate as a waiver of any subsequent default or breach.
26. **Entirety of Agreement:** The Client and the Contractor agree that this Agreement sets forth the entire agreement between the parties, and that there are no promises or understandings other than those stated herein. This Agreement supersedes all prior agreements, contracts, proposals, representations, negotiations, letters or other communications between the Client and Contractor pertaining to the Services, whether written or oral. None of the provisions, terms and conditions contained in this Agreement may be added to, modified, superseded or otherwise altered except by written instrument executed by the parties hereto.
27. **Modification:** The Agreement may not be modified unless such modifications are evidenced in writing and signed by both the Client and Contractor. Such modifications shall be in the form of a written Amendment executed by both parties.
28. **Contingent Fees:** The Contractor warrants that it has not employed or retained any company or person, other than a bona fide employee working solely for the Contractor to solicit or secure this Agreement and that it has not paid or agreed to pay any person, company, corporation, individual or firm, other than a bona fide employee working solely for the Contractor, any fee, commission,

percentage, gift or any other consideration contingent upon or resulting from the award or making of this Agreement.

- 29. **Truth-in-Negotiation Certificate:** Execution of this Agreement by the Contractor shall act as the execution of a truth-in-negotiation certificate certifying that the wage rates and costs used to determine the compensation provided for in this Agreement are accurate, complete, and current as of the date of the Agreement.
- 30. **Confidentiality:** No reports, information, computer programs, documentation, and/or data given to, or prepared or assembled by the Contractor under this Agreement shall be made available to any individual or organization by the Contractor without prior written approval of the Client.
- 31. **Miscellaneous:** Client expressly agrees that all provisions of the Agreement, including the clause limiting the liability of Contractor, were mutually negotiated and that but for the inclusion of the limitation of liability clause in the Agreement, Contractor's compensation for services would otherwise be greater and/or Contractor would not have entered into the Agreement.

In any action to enforce or interpret this Agreement, the prevailing party shall be entitled to recover, as part of its judgment, reasonable attorneys' fees and costs from the other party.



First Special Session Update: Governor Expands the “Call”

Immediately after the Eighty-Third Regular Legislative Session concluded, the governor called a special legislative session to deal with state and congressional redistricting. Even though the session was initially limited to that subject, lawmakers have filed bills on topics ranging from abortion to property taxes and everything in between. (All city-related bills are summarized in the *Legislative Update*, regardless of whether they are in the special session “call.”)

The governor has already chosen to add abortion and transportation funding to the special session call. In fact, the Senate Finance Committee held a hearing on 1S.J.R. 2, which would amend the Texas Constitution to allow the state to use a portion of the oil and gas production tax for transportation purposes, rather than sending all those funds to the state’s Rainy Day Fund, on June 12. The governor may add more topics in the coming days. The League will monitor any such items closely, and provide updates if the call is expanded to include more city-related issues.

First Special Session: City-Related Bills Filed

PROPERTY TAX

1H.B. 40 (E. Rodriguez) – Property Tax Appraisal: would: (1) for purposes of appraisal as “qualified open-space land,” require a chief appraiser to determine whether agricultural use meets the degree of intensity generally accepted in the area by considering the cumulative effect

of all agricultural uses of a tract of land, including producing fruits and vegetables and raising or keeping livestock; (2) require the comptroller to develop guidelines for determining whether land under 10 acres in size used for production of fruits, vegetables, poultry, hogs, sheep, or goats qualifies for appraisal as agricultural land; and (3) require the comptroller and the Texas A&M AgriLife Extension Service and other stakeholders to develop guidelines for determining whether land qualifies as a nonprofit community garden for appraisal as agricultural land.

1S.B. 32 (Patrick) – Revenue Cap: would: (1) lower the property tax rollback rate from eight percent to five percent; and (2) provide that a city must hold a ratification election to adopt a tax rate that exceeds the five percent rollback rate (as opposed to current law, which only requires an election if a petition is received from the citizens).

PURCHASING

1H.B. 39 (E. Rodriguez) – Local Preference: would provide that a local governmental entity that purchases agricultural products: (1) shall give preference to those produced or grown in this state if the cost to the local governmental entity is equal and the quality is equal; and (2) may give preference to those products produced or grown in this state if the cost to the local governmental entity does not exceed 107 percent of the cost of agricultural products produced or grown outside of this state and the quality is equal.

ELECTIONS

1H.B. 46 (Dutton) – Redistricting: would provide that: (1) an incarcerated person is included in the population data used for redistricting purposes, according to the person's last residence before incarceration; (2) each local governmental entity in this state that operates a facility for the incarceration of persons convicted of a criminal offense, including a mental health institution for those persons, or that places any person convicted of a criminal offense in a private facility to be incarcerated on behalf of the governmental entity, shall submit a report to the comptroller; (3) the governmental entity required to make a report under (2) shall ensure that the entity collects and maintains the information required; (4) each political subdivision of this state that elects any members of a governmental body from election districts, wards, or precincts that are subject to the one-person, one-vote requirement of the U.S. Constitution shall ensure that, after redistricting, each of those election districts, wards, or precincts does not vary from the average population of those districts, wards, or precincts according to the most recent adjusted population counts prepared by the comptroller under (2) by more than five percent; (5) a governmental entity to which the bill applies may exceed the adjusted population restrictions only to the extent necessary to comply with federal law or the Texas Constitution; and (6) the bill does not apply to any political subdivision or state governmental body before the comptroller makes the initial adjustment of census counts for the 2020 federal decennial census.

1S.B. 31 (Patrick) – Elections: would, among other things, change certain election dates as follows: (1) move the general primary election date to the first Tuesday in February in each even number year; (2) move the runoff primary election date to the fourth Tuesday in April following the general primary election; and (3) provide that the presidential primary election date is the first Tuesday in February in each presidential election year.

1S.B. 36 (Uresti) – Voter Registration: would provide that: (1) the secretary of state shall implement a program to allow a person to complete a voter registration application over the Internet; and (2) the secretary of state and the Department of Public Safety must provide a link to the location of the application on the official website of the state.

OPEN GOVERNMENT

1H.B. 43 (Callegari) – Public Retirement System Information: would: (1) provide that “individual record” information that could reasonably be expected to identify an individual who is or was a member, annuitant, retiree, beneficiary, alternate payee, program participant, or a person who is eligible to receive benefits from the same, is confidential and not subject to public disclosure, unless written authorization is obtained from the individual or individual’s representative; (2) allow the release of individual records and information in certain circumstances and to certain entities; (3) provide that the procedures of the Public Information Act prevail over any conflicting law with respect to the confidentiality of information held by a public retirement system; and (4) remove a public retirement system’s sole discretion in determining whether a record is confidential.

OTHER FINANCE/ADMINISTRATION BILLS

1H.B. 51 (Callegari) – Retirement Systems: would: (1) require each actuarially funded retirement system with an infinite amortization period to become finitely funded within six years or file a corrective action plan to do so with notice and participation by plan sponsors; (2) require each actuarially funded retirement system to become 80% funded and have an amortization period of 30 years or less; (3) prohibit any new monetary benefits that would result in a longer than 30 year amortization period for unfunded liabilities; (4) require a plan sponsor to make at least one contribution a year; (5) require that contributions be level or declining as a percentage of payroll; (6) require certain retirement systems that have over \$100 million in total assets to do an actuarial experience study; and (7) require each public retirement system to adopt ethical standards and conflict-of-interest policies at least as strict as state law.

1H.B. 54 (Flynn) – Capital Appreciation Bonds: would: (1) prohibit a county, city, special district, school district, junior college district, or other political subdivision from issuing capital appreciation bonds that are secured by property taxes unless: (a) the bonds have a scheduled maturity date that is not later than 20 years after the date of issuance; (b) the governing body of the political subdivision has received a written estimate of the cost of the issuance; (c) the governing body of the political subdivision has determined if any personal or financial relationship exists between members of the governing body and any financial advisor, bond counsel, bond underwriter, or other professional associated with the bond issuance; and (d) the governing body posts various information relating to the bond issuance on the political subdivision’s website; (2) provide that the total amount of capital appreciation bonds may not exceed 25 percent of the political subdivision’s total outstanding bonded indebtedness at the time of the issuance; and (3) provide that a county, city, special district, school district, junior college district, or other political subdivision may not extend the maturity date of an issued capital appreciation bond.

1S.J.R. 4 (Patrick) – Automatic Resignation: would amend the Texas Constitution to provide that a city councilmember who has a term of office of more than two years and announces his/her candidacy for another public office automatically resigns as a councilmember if he/she has more than one year and 60 days left in the city council term.

COMMUNITY AND ECONOMIC DEVELOPMENT

1S.B. 39 (Patrick) – Regulatory Takings: would provide: (1) that the application of any law, rule, policy, ordinance, or regulation that has the effect of requiring that more than fifty percent of the surface area of an owner's private real property remain in a natural or undeveloped state, exclusive of the 100-year floodplain as determined by agencies of the United States government, is a conservation easement, the establishment and enforcement of which will require: (a) the consent of the owner; or (b) the exercise of the power of eminent domain; and (2) exempt certain cities and actions from the provisions of the bill.

1H.B. 58 (Menéndez) – Alcohol/Sexually Oriented Businesses: would create a new "public consumption" alcoholic beverage permit to be administered by the Texas Alcoholic Beverage Commission and require certain sexually oriented businesses that operate as "BYOB" establishments to obtain the new permit.

PERSONNEL

1S.B. 30 (Patrick) – Immigration: would: (1) prohibit an employer, including a city, from employing an undocumented immigrant; (2) create a complaint process for employers that employ undocumented immigrants; (3) require the Texas Workforce Commission to adopt rules regarding the bill; and (4) require a report by the commission to be given to the legislature and the governor based on nonidentifiable, summary data of two years of complaint data.

PUBLIC SAFETY

1H.B. 34 (Gooden) – Handguns: would authorize: (1) a prosecutor who holds a concealed handgun license to carry essentially anywhere; and (2) such a prosecutor to carry a handgun in a concealed or open manner.

1H.B. 38 (Sheets) – Concealed Handguns: would authorize certain federal judges and prosecutors who hold a concealed handgun license to carry essentially anywhere.

1H.B. 45 (Pickett) – Commercial Driver's Licenses: would: (1) authorize the issuance of a commercial learner's permit available for drivers that meet certain criteria; and (2) prohibit texting while driving by the operator of a commercial motor vehicle.

1H.B. 49 (Springer) – Concealed Handguns: would provide that: (1) a concealed handgun license holder is authorized to carry a concealed handgun essentially anywhere; and (2) authorize a concealed handgun license holder to display a handgun under circumstances in which he or she would have been justified in the use of force or threat of force.

1H.B. 56 (Lavender) – Handguns: would, among many other things, authorize a concealed handgun license holder to openly carry a handgun.

1S.B. 34 (Campbell) – Concealed Handguns: would authorize a concealed handgun license holder to carry a concealed handgun: (1) in a polling place, an amusement park, on the premises of a racetrack, a hospital, church, synagogue, or other established place of religious worship; and (2) at a meeting of a governmental body if the license holder has not received effective notice that carrying at the meeting is prohibited.

1S.B. 35 (Carona) – Concealed Handguns: would authorize certain prosecutors who hold a concealed handgun license to carry essentially anywhere.

1S.B. 27 (Huffman) – Controlled Substances: would designate certain additional synthetic cannabinoids as controlled substances and controlled substance analogues under the Texas Controlled Substances Act.

1S.B. 28 (Huffman) – Controlled Substances: would add certain substances to Penalty Groups 1-A and 2 of the Texas Controlled Substances Act.

1S.B. 40 (Nichols) – Commercial Driver’s Licenses: this bill is identical to **H.B. 45** by **Pickett**, above.

1S.B. 41 (West) – Firearms: provides, among other things, that a person commits an offense if he purchases or attempts to purchase a firearm with intent to deliver the firearm to a person knowing that the person to whom the firearm is to be delivered intends to possess the firearm unlawfully or to use the firearm unlawfully or in the commission of an unlawful act.

UTILITIES AND ENVIRONMENT

1H.B. 50 (Callegari) – Desalination: would: (1) require the Texas Commission on Environmental Quality to adopt rules to allow water treated by a desalination facility to be used as public drinking water and ensure that the water treated by a desalination facility meets all state and federal law requirements; and (2) establish the Texas Center for Innovative Desalination Technology as a partnership between the University of Houston, The University of Texas at Brownsville, and the University of Texas at El Paso.

TRANSPORTATION

1H.B. 23 (Pickett) – Transportation Funding: would: (1) authorize the Texas Department of Transportation to require a person, including a governmental or private entity, to obtain a permit and pay a fee as a condition of using any part of a state highway right-of-way for the construction, maintenance, or operation of a utility facility; but (2) provide that the department may not require the payment of a fee from a city.

1H.B. 28 (Harper-Brown) – Transportation Funding: would authorize the Texas Department of Transportation to enter into “availability payment agreements” for the design, development, financing, construction, maintenance, or operation of a highway project. (Note: An availability payment contract is a form of public/private partnership under which a governmental entity makes fixed payments to a private contractor that is responsible for the design, construction, long term maintenance, and financing of the project.)

1H.B. 35 (Phillips) – Transportation Funding: would end the diversion of gas tax revenues that currently fund the Texas Department of Public Safety and require that those funds be deposited into the state highway fund.

1H.B. 41 (Pickett) – Transportation Funding: would end the diversion of gas tax revenues that currently fund the available school fund and require that those funds be used mainly for transportation funding.

1H.B. 52 (Harper-Brown) – Transportation Funding: would end the diversion of gas tax revenues that currently fund the available school fund.

1H.B. 62 (Flynn) – Slow Moving Vehicles: would provide that a “slow moving vehicle (a motor vehicle designed to operate at a maximum speed of 25 miles per hour or less) may drive on an improved road shoulder.

1H.B. 65 (Frank) – Transportation Funding: would provide that, beginning in increments in 2015 and completed in 2018, the net revenue derived from the state sales tax imposed on the sale of a motor vehicle sold in this state shall be deposited to the credit of the state highway fund.

1H.J.R. 16 (Pickett) – Transportation Funding: would amend the Texas Constitution to provide that certain amounts of the state’s gas tax and oil and gas revenues be used for transportation purposes.

1H.J.R. 17 (Harper-Brown) – Transportation Funding: would amend the Texas Constitution to end the diversion of gas tax revenues that currently fund the available school fund.

1S.B. 33 (Lucio) – Transportation Funding: would provide that the sales tax imposed on automotive accessories (e.g., aftermarket modifications and electronics, cleaning products, floor mats, air fresheners, paint, and window tinting) shall be deposited into the state highway fund.

1S.J.R. 5 (Lucio) – Transportation Funding: would amend the Texas Constitution to provide that the sales tax imposed on automotive accessories shall be deposited into the state highway fund.

Governor's Vetoes Include City-Related Bills

Governor Rick Perry has vetoed 26 bills passed by the legislature during the regular session. Seven of the 26 were city-related bills described in the League's "wrap-up" *Legislative Update* on May 27. Those seven vetoes are detailed below:

- **H.B. 950 (Thompson/Davis) – Employment Discrimination:** tracks the language of the federal Lilly Ledbetter Fair Pay Act (a 2009 law that overturned a U.S. Supreme Court decision that the statute of limitations for presenting an equal pay lawsuit begins on the date that the employer makes the initial discriminatory wage decision, not at the date of the most recent paycheck) by: (1) extending the statute of limitations on pay discrimination claims to include every instance an individual is paid based on a past discriminatory decision made by an employer; and (2) allowing back pay and benefit damages for up to two years preceding the date of filing a complaint for pay discrimination.

According to the governor's veto message, "Texas' commitment to smart regulations and fair courts is a large part of why we continue to lead the nation in job creation. House Bill 950 duplicates federal law, which already allows employees who feel they have been discriminated against through compensation to file a claim with the U.S. Equal Employment Opportunity Commission."

- **H.B. 1982 (Murphy/Hinojosa) – Enterprise Zones:** this bill, among other things: (1) authorizes a county to nominate for designation as an enterprise project or activity of a

qualified business that is located within the jurisdiction of city located in the county only if the nominating county enters into an interlocal agreement with the city that has jurisdiction of the territory in which the nominated project or activity will be located; (2) requires that the interlocal agreement specify that either the nominating county or the city that has jurisdiction of the territory in which the nominated project or activity will be located is the governmental body having administration authority and that both the city and the county approve the nomination; and (3) requires the nominating city or county to submit: (a) a certified copy of the minutes of all public hearings regarding local incentives available to qualified businesses with the nominating body's jurisdiction; and (b) any interlocal agreement that states which governing body has administration authority and that both the city and the county approve the nomination of the project or activity.

According to the governor's veto message, "I applaud the intent of House Bill 1982 to improve the enterprise zone program by requiring projects that get the biggest tax refunds to create more jobs rather than focusing on job retention. However, H.B. 1982 also contains ambiguous language which could hurt, rather than help, the program. Therefore, I...will recommend that the lieutenant governor and speaker of the House conduct an interim study to review this issue and ways to improve the program."

- **S.B. 1606 (Zaffirini/Strama) – Property Tax Liens:** provides that a tax lien on inventory, furniture, equipment, or other personal property attaches to all such property that is owned on January 1 of the year the lien attaches, irrespective of whether the personal property is located within the boundaries of the taxing unit in whose favor the lien attaches.

According to the governor's veto message, the bill "would provide that a taxing authority has an annual lien that automatically attaches to all business personal property that the business owns in the state, including property outside the taxing authority's jurisdiction. Current law gives taxing units authority to deal with taxpayers who move property around the state in an attempt to avoid taxation, while also protecting taxpayers from overly aggressive taxing authorities. By providing taxing authorities with an automatic lien on property they do not have the authority to tax, this bill could lead to abusive taxing authorities overextending their reach, to the detriment of smaller taxing units and taxpayers."

- **S.B. 722 (Ellis/Johnson) – Interpreters:** allows the authority ordering an election to either use an interpreter selected by a voter or to select an interpreter for a voter, and provides that to be eligible to serve as an interpreter, a person: (1) if selected by the voter, may be any person other than the voter's employer, an agent of the voter's employer, or an officer or agent of a labor union to which the voter belongs; or (2) if appointed to serve as an interpreter by the authority ordering the election, must be a registered voter of the county in which the voter needing the interpreter resides or a registered voter of an adjacent county.

According to the governor's veto message, "Ensuring the integrity of our state's election process is a key component of providing a system of fair, open and honest elections. Under current law, if a voter cannot communicate with poll workers in a common language, the voter is entitled to use an interpreter of the voter's choice who is a registered voter in that county. Often, this is a family member or other person in whom the voter personally has confidence...the elimination of the requirement that an interpreter selected by the voter be from the county will lead to the likelihood of undue influence being placed on the voter to agree to 'select' activists from outside the area with whom the voter is not familiar."

- **S.B. 1234 (Whitmire/Price) – Failure to Attend School:** changes the penalties for the offense of failure to attend school including setting up alternatives to fines and providing for additional truancy resources in schools and allows a city to employ a juvenile case manager.

According to the governor's veto message, "Senate Bill 1234 attempts to change how truancy is handled by placing progressive sanctions on students based on recommendations established in a behavioral improvement plan. While these plans are meant to hold students accountable for attendance and behavior management, they do not track the child from district to district and are lost as a student transfers from one school to another, which is common for chronically truant students. Senate Bill 1234 will hurt established local programs and prevent schools from identifying and helping address the issues students are facing. Additionally, S.B. 1234 conflicts with other legislation, such as S.B. 393, concerning which truanancies are considered a ticketable offense."

- **S.B. 219 (Huffman/Bonnen) – Texas Ethics Commission:** among other things, this bill: (1) makes various changes in regard to the functions and duties of the Texas Ethics Commission, including: (a) changing the system by which ethics violations/alleged violations are categorized and handled; and (b) requiring the commission to design forms that may be used for filing a financial statement with an authority other than the commission (e.g., a city); (2) changes the financial disclosure statement requirements in cities with 100,000 or more in population to provide that: (a) a statement may be filed with the city clerk or secretary by electronic mail, and the clerk or secretary may prescribe guidelines for filing by electronic mail; and (b) a financial statement that is not filed by electronic mail is timely filed if it is properly addressed and placed in the U.S. post office or with a common or contract carrier not later than the last day for filing; and (3) amends the definition of "political advertising" to include communications transmitted by an automated dial announcing device and adds some political advertising disclosure requirements.

According to the governor's veto message, "S.B. 219 contains several important changes to the state's ethics laws, especially those relating to the sworn complaint process. However, these positive changes are outweighed by several provisions added late in the legislative process without an open and honest discussion. The Legislature had an opportunity, through the sunset review process, to make needed changes to our campaign finance, lobby, and financial disclosure laws – changes that are needed to modernize laws

while still protecting our rights and providing for transparency. I urge the Legislature to look closely at our ethics laws during the interim in an open, deliberative, and transparent way, so that all voices are heard and all proposals are thoroughly discussed.”

- **H.B. 1511 (Larson/Eltife) – Local Sales Tax Rate:** this bill: (1) allows a city to hold an election to impose a dedicated sales and use tax for sports and venue districts, crime control and prevention districts, economic development corporations, property tax relief, or street maintenance at any rate that is an increment of one-eighth of one percent that would not result in a combined rate that exceeds the maximum local sales and use tax rate of two percent; (2) allows a city to hold an election to impose its general sales and use tax at any rate that is an increment of one-eighth of one percent that it would not result in a combined rate that exceeded the maximum local sales and use tax rate of two percent; and (3) extends from four years to eight years the expiration date on the dedicated sales and use tax for street maintenance. (Note: This bill was not summarized in the May 27 “wrap-up”.)

According to the governor’s veto message, “House Bill 1511 would restrict Texans’ power to vote to maintain or increase a street maintenance tax. This bill would allow municipalities to delay voter input by limiting the tax elections to once every eight years rather than the current four-year period. Texans should have the right to vote on tax measures sooner rather than later.”

Texas Supreme Court Defines “Law” for Purposes of the Whistleblower Act

A claim under the Texas “Whistleblower Act” arises when an employee is terminated or disciplined after alleging a violation of “law” to an appropriate party. The Act allows such an employee to file suit alleging that he or she was terminated for reporting a violation of law, rather than for a legitimate reason.

On June 14, in *University of Houston v Barth*, the Texas Supreme Court reviewed the issue of whether a “law” includes a “rule adopted under a statute or ordinance.” The court concluded that, in addition to a report of a violation of a state law, a claim could be based on an ordinance or personnel policy adopted by ordinance.

Each city should consult with legal counsel to review its ordinances and policies to determine whether, among other things, its personnel policy was adopted by ordinance, and to determine whether any changes could help avoid a Whistleblower lawsuit.

Recent Legislation Impacts City Budget and Tax Rate Process

Two bills were recently passed that will affect a city's budget adoption and property tax rate setting process:

- **S.B. 656 (Paxton/Button)** requires that additional actions and notice be provided by the city when it adopts its budget. More specifically, the bill: (1) requires the city council's vote to adopt a budget to be a record vote; (2) requires an adopted budget to contain a cover page that includes: (a) a specific statement on whether the budget raises more, less, or the same amount of property tax revenue compared to the previous year's budget; (b) the record vote of each member of the governing body by name voting on the adoption of the budget; (c) the city property tax rates for the preceding and current fiscal years, including the adopted rate, effective tax rate, effective maintenance and operations tax rate, rollback tax rate, and debt rate; and (d) the total amount of city debt obligations secured by property taxes; (3) requires a city with a website to post the cover page in (2), above, on the city's website, and keep the record vote information on the city's website for at least one year after the budget is adopted; and (4) requires the city council to amend the cover page to include the property tax rate information for the current fiscal year if the rates are not included on the cover page when the budget is filed with the city secretary.

S.B. 656 is effective beginning September 1, 2013, and applies to a budget adopted for a fiscal year beginning on or after September 1, 2013. Therefore, cities will need to comply with the requirements of S.B. 656 beginning with the upcoming budget adoption process. The full text of the bill is available at:

- **S.B. 1510 (Hinojosa/Hilderbran)** is a good bill for Texas cities and taxpayers alike. The bill will, for *next year* (i.e., 2014), simplify property tax rate setting process and notice requirements. The full text of the bill is available at:

Again, unlike S.B. 656, S.B. 1510 is not effective until January 1, 2014. *Cities should not use its provisions until the tax rate setting process in 2014.*

TCEQ Now Accepting Applications for Municipal Solid Waste Advisory Council

The Texas Commission on Environmental Quality (TCEQ) is now accepting applications for the Municipal Solid Waste Management and Resource Recovery Advisory Council. Council members are appointed for six-year staggered terms by the TCEQ Commissioners. The duties of the Advisory Council include:

- reviewing and evaluating the effect of state policies and programs on municipal solid waste management;
- making recommendations to the TCEQ commissioners on matters relating to municipal solid waste management;
- recommending legislation to encourage the efficient management of municipal solid waste;
- recommending policies for the use, allocation, or distribution of the planning fund that includes identification of statewide priorities for use of funds, the manner and form of application for financial assurance, and criteria, in addition to those to be evaluated in establishing priorities for providing financial assistance to applicants;
- recommending special studies and projects to further the effectiveness of municipal solid waste management and resource recovery.

The deadline to apply is July 12, 2013.

Governor's Office Seeking Information on ADA Coordinators

The governor's office is seeking contact information for each Americans with Disabilities Act (ADA) coordinator in the state. (Federal law requires a city with 50 or more employees to designate at least one responsible employee to coordinate ADA compliance. The requirement does not apply to cities with fewer than 50 employees.)

The purpose of gathering the contact information in one location is to be able to refer individuals to the appropriate coordinator and eventually provide networking and problem-solving opportunities to ADA coordinators throughout the state.

First Special Session: Significant Floor Actions

1S.J.R. 2 (Nichols), relating to the transfer of certain general revenue to the state highway fund and the economic stabilization fund and to authorize the payment from the state highway fund of the principal and interest of certain highway improvement bond. Passed the Senate.

First Special Session: City-Related Bills Filed

PROPERTY TAX

1H.B. 83 (Flynn) – Capital Appreciation Bonds: would: (1) prohibit a county, city, special district, school district, junior college district, or other political subdivision from issuing capital appreciation bonds that are secured by property taxes unless: (a) the bonds have a scheduled maturity date that is not later than 20 years after the date of issuance; (b) the governing body of the political subdivision has received a written estimate of the cost of the issuance; (c) the governing body of the political subdivision has determined if any personal or financial relationship exists between members of the governing body and any financial advisor, bond counsel, bond underwriter, or other professional associated with the bond issuance; and (d) the governing body posts various information relating to the bond issuance on the political subdivision's website; (2) provide that the total amount of capital appreciation bonds may not exceed 25 percent of the political subdivision's total outstanding bonded indebtedness at the time of the issuance; and (3) provide that a county, city, special district, school district, junior college district, or other political subdivision may not extend the maturity date of an issued capital appreciation bond.

COMMUNITY AND ECONOMIC DEVELOPMENT

1H.B. 69 (Callegari) – Eminent Domain Reporting: would amend the provisions of S.B. 18 (2011) to provide that an entity, including a city, that did not submit the required letter to the comptroller describing its power of eminent domain prior to December 31, 2013, may not exercise the entity's power of eminent domain before the 90th day after the date the entity submits a letter to the comptroller. (Note: Under S.B. 18, a city that did not submit a letter by the deadline may not exercise the power of eminent domain. This bill would give those cities that missed the deadline the ability to submit and once again use the power of eminent domain.)

1S.J.R. 8 (Campbell) – State Rainy Day Fund: would amend the Texas Constitution to provide that the legislature may, by a two-thirds vote of the members present in each house, appropriate amounts from the economic stabilization fund to: (1) repay state debt; (2) reduce state taxes; (3) pay costs associated with a state of disaster declared by the governor; or (4) pay costs associated with a natural disaster or an emergency identified by the legislature.

PUBLIC SAFETY

1H.B. 71 (Flynn) – Emergency Vehicles: would provide that: (1) on the immediate approach of a police vehicle using an audible or visual signal, an operator, unless otherwise directed by a police officer, must yield the right-of-way, move as far as possible to the right edge or curb of the road, and stop until the authorized emergency vehicle has passed; and (2) the operator of an authorized emergency vehicle may proceed through a signal, exceed the speed limit, and disregard a regulation governing the direction of movement or turning if the vehicle is: (a) responding to an emergency call; (b) pursuing a violator; (c) responding to a fire alarm; (d) directing or diverting traffic for public safety; or (e) conducting a police escort (the criteria in (a)-(e) would not apply to parking or standing an emergency vehicle).

1H.B. 79 (White) – Juvenile Facilities: would add juvenile facilities and correctional officers at juvenile facilities to the Penal Code provision prohibiting improper sexual activity with individuals in custody.

1H.B. 84 (White) – Official Oppression: would, for purposes of the offense of official oppression, define “public servant” to include: (1) an officer, employee, or agent of: (a) the United States; (b) a branch, department, or agency of the United States; or (c) another person acting under a contract with a branch, department, or agency of the United States to provide a security or law enforcement service; or (2) any other person acting under color of federal law.

TRANSPORTATION

1H.J.R. 19 (Harper-Brown) – Transportation Funding: would amend the Texas Constitution to: (1) provide for the transfer of general revenue to the state highway fund and the economic stabilization fund; and (2) authorize the payment from the state highway fund of the principal and interest on certain highway improvement bonds.

1S.J.R. 9 (Davis) – Transportation Funding: would amend the Texas Constitution to: (1) provide for the transfer of certain general revenue to the state highway fund, the foundation school fund, and the economic stabilization fund; and (2) authorize the payment from the state highway fund of the principal and interest on certain highway improvement bonds.

SUBJECT: Resolutions for the 2013 TML Annual Conference

In order to facilitate the development of policy, the TML Constitution provides a resolutions process that allows input from TML member cities, regions, and affiliates. It is through this process that issues most important to the cities of Texas are identified and decisions are made regarding the allocation of the League's legislative and administrative resources.

The TML Constitution states that resolutions for consideration at the Annual Conference must be submitted to the TML headquarters 45 calendar days prior to the first day of the Annual Conference. For 2013, this provision means that resolutions from any member city, TML region, or TML affiliate must arrive at the TML headquarters no later than **August 26, 2013**.

The TML Board of Directors has adopted several procedures governing the resolutions process. Please review the following items carefully and thoroughly.

1. No resolution can be considered by the TML Resolutions Committee unless it has prior approval of: (a) the governing body of a TML member city; (b) the governing body or membership of a TML affiliate; **or** (c) the membership of a TML region at a regional meeting.
2. TML member cities, regions, and affiliates that wish to submit a resolution **must** complete a resolution cover sheet. The cover sheet to be used is attached. Please feel free to make as many copies of this cover sheet as needed. The cover sheet must be attached to the resolution throughout each step of the resolutions process.
3. It is recommended that any resolution should state one of four categories of action to better direct League staff. Those categories are:

- **Seek Introduction and Passage** means that the League will attempt to find a sponsor, will provide testimony, and will otherwise actively pursue passage. Bills in this category are known as “TML bills.”
- **Support** means the League will attempt to obtain passage of the initiative if it is introduced by a city or other entity.
- **Oppose.**
- **Take No Position.**

Please see the attached “Legislative Policy Development Process and Schedule” for more information.

4. Resolutions submitted will be thoroughly discussed at the TML Annual Conference. The Resolutions Committee is appointed by the TML President and is made up of city officials from TML member cities across the state.
5. The city or other entity that submits a resolution is encouraged to send a representative to the Resolutions Committee meeting to explain the resolution. The Resolutions Committee will meet at **2:00 p.m.** on **Tuesday, October 8, 2013,** at the **Austin Convention Center.**

If the procedures described above are not followed for any given resolution, that resolution is likely to be referred to some other TML committee for further study. In that case, the resolution would not be adopted during the 2013 conference.

You should also be aware that under the TML Constitution, resolutions received after the deadline of August 26, 2013, must not only have the attached cover sheet, but also must “state the reason precluding timely submission.” These late resolutions can be considered by the TML Resolutions Committee at the Annual Conference only if two-thirds of the Committee members present and voting agree to suspend the submission rule and consider the resolution.

The Texas Municipal League's 2015/2016 Legislative Policy Development Process and Schedule

City officials across the state are well aware of the fact that many significant decisions affecting Texas cities are made by the Texas Legislature, not by municipal officials. Newly elected mayors and councilmembers quickly realize that cities are indeed “creatures of the state.” This subservient position of cities in the state’s intergovernmental system means that the legislature can address virtually any aspect of city government.

This fact is vividly demonstrated during each legislative session. For example, during the 2013 session, more than 6,000 bills or significant resolutions were introduced; almost 1,500 of them would have affected Texas cities in some substantial way. In the end, over 1,700 bills or resolutions passed and were signed into law; approximately 220 of them impacted cities in some way.

There is no reason to believe that the workload of the 2015 session will be any lighter; it may be greater. And for better or worse, city officials will have to live with all the laws that may be approved by the legislature. Thus, the League must make every effort to assure that detrimental bills are defeated and beneficial bills are passed.

The TML approach to the 2015 session will undoubtedly be guided by principles that spring from a deeply rooted TML legislative philosophy:

- The League will vigorously oppose any legislation that would erode the authority of Texas city officials to govern municipal affairs.
- Cities represent the level of government closest to the people. They bear primary responsibility for the provision of capital infrastructure and for ensuring our citizens’ health and safety. Thus, cities must be assured of a predictable and sufficient level of revenue and must resist efforts to diminish that revenue.
- The League will oppose the imposition of any state mandates that do not provide for a commensurate level of compensation, and resist any attempts to require cities to raise money for the state (reverse intergovernmental aid).

Schedule

Throughout 2014, legislative policy committees will help TML prepare legislative positions. The League’s legislative policy development schedule will be roughly as follows:

October 2013 – the 2013 TML Resolutions Committee will meet to consider resolutions. The recommendations of the Resolutions Committee will go forward for consideration by the TML membership on the final day of the 2013 Annual Conference at the annual business meeting.

January - February 2014 – the chairs, vice-chairs, board representatives, and members of the League’s legislative policy committees will be appointed by the TML President.

May - June 2014 – the committees will meet for the first time.

June - July 2014 – any subcommittees appointed by the committees will meet.

August 2014 – the committees will combine to form the General Government Committee, at which time they will finish their topic-specific work and consider additional items.

September - October 2014 – the reports of the legislative policy committees will go forward to the 2014 TML Resolutions Committee for consideration. The recommendations of the Resolutions Committee will go forward for consideration by the TML membership on the final day of the 2014 Annual Conference at the annual business meeting.

December 2014 – the TML Board will finalize the League’s 2015 legislative program based on resolutions passed in both 2013 and 2014.

Some Suggestions

As can be seen from the section above, the legislative policy committees provide the framework for the TML legislative policy development process. As an integral part of that committee process, you can significantly impact the outcome of the 2015 legislative session. As you undertake your committee work, you should keep in mind the following:

1. **There is a practical limit to what the League – or any group, for that matter – can accomplish in any legislative session.** It is obvious that all resources – human, financial, and political – are limited, and no group can hope to achieve all its legislative objectives. The most powerful interest groups in the state sometimes come away from a legislative session bruised and battered. On occasion, the best that can be expected is that no harm be done.
2. **TML will expend the vast majority of its resources killing bad bills.** This has always been so and will probably always be the case. At one point during the 2013 regular session, the League was monitoring more than 1,700 bills or resolutions, many of which were bad for cities. The League’s legislative philosophy has traditionally been, first and foremost, to defeat bad legislation and, secondarily, to seek passage of beneficial legislation as time, resources, and political realities permit.

It is unlikely that any other interest group in the state monitors and opposes as many bills as does the Texas Municipal League. During recent legislative sessions, the League took steps to oppose bad legislation dealing with everything from annexation to zoning and from birth records to cemeteries. The breadth of the League's legislative focus becomes obvious each year when TML completes and submits its state-mandated lobbyist registration form. One schedule of the form asks which of 83 subject matters are of interest to TML. Of the 83, only four fall outside the League's areas of interest.

Unfortunately, the number of bad city-related bills grows almost every year. (Please see the chart below.) As a result, the League has been forced to expend an ever-greater percentage of its resources simply fending off bad ideas.

3. **Given the League's finite resources, and because vast amounts of those resources are necessarily expended in defeating bad legislation, the League must very carefully select bills that it will support or for which it will attempt to seek passage.** A sharply focused legislative program is more likely to lead to success than is a very large and wide-ranging program. In addition, supporting a bill that has a low probability of passage requires a large amount of time and political resources that can be used more productively in other ways. **Thus, it is important to advocate only those initiatives that are truly important and that have a realistic chance of passage.**

4. How can the committee identify initiatives that are truly significant and that merit a place in the TML legislative program? Committee members may wish to ask the following questions about each discussion item:
 - ◆ **Does the initiative have wide applicability to a broad range of cities of various sizes (both large and small) and in various parts of the state?**

- ◆ **Does the initiative address a core municipal issue, such as erosion of local control and preservation or enhancement of municipal revenue?**
- ◆ **Will the initiative be vigorously opposed by strong interest groups and, if so, will member cities commit to contributing the time and effort necessary to overcome that opposition?**
- ◆ **Is this initiative, when compared to others, important enough to be part of TML's list of priorities?**
- ◆ **Is this initiative one that city officials, more than any other group, should and do care about?**

The foregoing suggestions are not meant to imply that TML can't pass good, solid legislation. It can, it has in the past, and it will again. The suggestions are meant merely to emphasize the fact that any group, to succeed, must use its resources and its political strength wisely and selectively.

Categories

Submissions should reflect one of four categories that will direct League staff. Keep in mind that there is a difference between "seek introduction and passage" and "support."

- **Seek Introduction and Passage** means that the League can attempt to find a sponsor, will provide testimony, and will otherwise actively pursue passage. Bills in this category are known as "TML bills." **These bills require an enormous amount of time and resources, and the committee should be very cautious about putting items in this category.**
- **Support** means the League will attempt to obtain passage of the initiative if it is introduced by some other entity. **League staff will, based upon the foregoing principles and its intimate knowledge of the legislature, determine the amount of time and resources devoted to an item in this category.**

With very few exceptions, any item that makes its way into the 2015/2016 TML Legislative Program should be couched in the two terms described above or by recommending that TML "**oppose**" or "**take no position**" on an issue.
